#### Resolution No.: 2013 05 48

(Henuset/Forsyth) "Now Therefore Be It Resolved that the quote of \$3,975.00 plus GST from Patmore Nursery Sales be accepted for the purchase and planting of trees at the Public Works Building." Carried 7/0

#### Resolution No.: 2013 05 49

(Martin/Forsyth) "Now Therefore Be It Resolved that the quote from Badger Excavating for the demolition of the former Sinclair Hall building located on Lot 18, Block 2, Plan 135 in Sinclair in the amount of \$4,290.00 plus taxes be accepted." Carried 7/0

## **Roads**

- Stipulate start date and list number of working days from start date and completion date will be October 31st.
- Add compaction testing at R.M. cost
- Who is getting materials?
- Should put at date site meeting before it is bid

## Gravel

Gravel inventory, pricing, needs, etc. were discussed and future gravel needs will be presented at the next Public Works meeting.

## **Resolution No.: 2013 05 51**

(Duncan/Henuset) "Now Therefore Be It Resolved that the R.M. of Pipestone purchase an SP 100 Radar sign from Airmaster Signs at the quoted price of \$3,383.00 plus taxes (no Bluetooth)." Carried 7/0

A Council may not give a proposed by-law more than two readings at the same Council meeting.

And Whereas By-law 2013-07, being a by-law of the R.M. of Pipestone to establish a tax sale manager position, has received first reading;

Now Therefore Be It Resolved that By-law 2013-07 be referred for second and third readings."
